REACH Regulation / SVHC list

The REACH Regulation (EC) No. 1907/2006, which has been in force since June 2007, affects manufacturers, processors and customers in all sectors of the economy. Today we would like to inform you about the current status of REACH in our company. Against the background of a high level of supply and product safety and in our own interest, we take our duty to inform very seriously.

According to Article 3 of the REACH Regulation, A+C Plastic is a downstream user and our film products are "articles". We have no obligations to register substances or to issue safety data sheets on substances and mixtures.

We require our suppliers to provide us with binding information on the use or content of listed SVHC substances. From today's perspective, it cannot be assumed that our products contain SVHC substances in a mass concentration of more than 0.1 per cent. For this reason, we have no obligation to report to the so-called SCIP database (Substances of Concern in Products) since 5 January 2021. The list of substances of very high concern (SVHC) is published and available on the website of the European Chemicals Agency (ECHA) as of 22 Januar 2025.

As our raw materials do not contain any SVHC and we do not add any other SVHC, our products do not contain any substances on the list in Annex XIV of the REACH Regulation (EC) No. 1907/2006.

As a processor of plastic pellets, A+C Plastic is aware of its obligations in Annex XVII No. 77, "Synthetic polymer microparticles". We participate in the "Zero Pellet Loss" initiative of the "Industrievereinigung Kunststoffverpackungen".
