Store at 50% rel. humidity

Storage for extended periods of time, in particular at increased temperatures, may result in an aging of the film surface (in case of pressure pre-treated film, the strength of the pre-treatment is reduced).

Due to this and the effects of the rays of the sun, the technical and

sensoric characteristics become poorer (smell, effect on taste).

The task of the party doing the further processing is to examine the technical and sensory suitability in accordance with the corresponding regulation at the time of processing.
