REACH-Regulations / SVHC-List

The REACH-Regulations were introduced in June 2007 in-line with the EU Regulations 1907/2006. They concern manufacturers, processors and a clientele from all sectors of industry.

A+C Plastic see themselves as a “downstream user”, following the definition of the REACH-Regulations. Products made by A+C Plastic therefore are not subjected to the obligation to pre-register or to register.

Nevertheless, we take our obligation to provide information very seriously as this is in our best Interest in view of providing a high degree of supply and production safety.

It is against this background that we would like to inform you from today's perspective of the latest news on this vast topic.

The products manufactured by us in compliance with Article 3 of the REACH Regulations do not contain any constituents in-line with Article 7 (1); neither do they contain hazardous substances (Article 7 (2)) at a level of concentration exceeding 0.1 percent of mass.

The List of Substances of Very High Concern (SVHC) has been publicized on the web page of the European Chemicals Agency (ECHA), updated Jun 25 / 2020, and can be downloaded.

We have asked our suppliers to provide us with information on the use or the contents of listed SVHC substances. From today's vantage point of our suppliers it cannot be assumed that our products contain SVHC substances exceeding a concentration of 0.1 percent of mass.
